



## **PERSONAL DATA PROCESSING POLICY - REGULATION (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL (GDPR, Article 13)**

In accordance with the EU General Data Protection Regulation (GDPR 2016/679, Article 13), you are hereby informed that personal data which you voluntarily make available to iGuzzini illuminazione S.p.A. (hereafter, also, "the Company" or "iGuzzini") will be processed in accordance with the current personal data protection regulations and, in any case, with the principles of correctness, lawfulness and confidentiality on which the Company's business is based.

### **1 - Purpose of processing**

The personal data that you have made available to iGuzzini in order to participate in the Competition for Ideas - Light For Future 2022 Project (Competition) is processed by the Controller in accordance with the current personal data protection regulations.

The personal data will be processed exclusively in order to fulfil the following purposes:

- following your optional specific consent only, your personal data will be processed in order to allow and manage your registration for the Competition, complete the selection procedure, draw up the list of participants, and implement the on-line and/or off-line communication plan that iGuzzini may freely adopt, as well as use your image, in relation to the Competition.

In relation to the purpose mentioned in the preceding point, providing your personal data and consenting to its processing is optional, but you will be unable to participate in the Competition if you fail to provide your data and consent or if the data you provide is incomplete.

### **2 - Processing methods**

Your data will be processed by specially authorised people in such a way as to guarantee security and confidentiality through paper-based or possibly automatic tools to store, manage or transmit the data, with the possibility of communicating and processing it for the purpose stated above in accordance with the current regulations.

### **3 - Recipients or Categories of recipients of the personal data**

The Marketing Office and Information Technology Office of our Company, and third parties involved in the Competition as promoters and sponsors may be informed of your personal data.

Your personal data may be disclosed to

- private or public parties whose right to access your personal data is recognised by legal provisions or by secondary or EC regulatory provisions
- companies and bodies responsible for processing personal data on our behalf, which perform specific processing services or carry out activities related to, instrumental to, or to support that of our Company within the limits strictly necessary to carry out the activities assigned to them, and after undertaking to respect the confidentiality and security of your data while processing it.

### **4 - Data Transfer to a Third Country**

Your data will not be transferred outside the EU.

### **5 - Criteria used for storage of the data**

Your data will be kept for no longer than the time needed to achieve the purpose for which it is processed. Therefore, the data collected for participation in the Competition will be kept for as long as necessary to complete the competition procedures and allow our Company to implement the communication plan. If you so request, we will delete your data from the systems/archives in which it is held.

### **6 - Privacy rights of the data subject**

You are hereby informed that, regarding your data, at any time you may exercise the rights envisaged according to the limits and conditions of articles 15 to 22 of the GDPR 2016/679.

Appropriate feedback to such a request will be given without delay within 30 days.

In detail, you, the data subject, have the right to:

- ask the Controller for access to, rectification or erasure ("Right to be forgotten") of the personal data, or restriction of processing concerning your personal data, or to object to its processing;
- obtain data portability;
- lodge a complaint with a Supervisory Authority.
